Transition from IAIABC EDI Claims Release 1.0 and Paper Reporting to IAIABC EDI Claims Release 3.0 for First Report of Injury (FROI) and Subsequent Report of Injury (SROI)

Updated: 3/21/2017

The 2016 Idaho Legislature approved amendments to IDAPA 17.02.06 and 17.02.07 that mandate the submission of workers' compensation claims information to be reported electronically to the Commission effective November 4, 2017.

Idaho Industrial Commission (IIC) will not accept paper forms (IC Form 1A-1 Employers First Report of Injury or Illness) from carriers, self-insured employers or claims administrators after the mandate date November 4, 2017.

All paper forms (IC Form 1A-1 Employers First Report of Injury or Illness) not received by IIC on November 3, 2017 by 5:00 PM MST, must be submitted electronically per the Event Table effective on the mandate date November 4, 2017.

An exception is Lump Sum Settlements pursuant to Idaho Code 72-404. Lump sum Settlements will continue to be handled via paper, with the appropriate payment transaction(s) submitted via EDI after approval of the settlement by the Commission. Below are the IIC requirements and implementation guidelines.

Guidelines for Transition for Trading Partners that currently report via IAIABC EDI Claims Release 1.0 Reporting and Paper Reporting:

IAIABC EDI Claims Release 1.0 Reporting:

1. On or before March 17, 2017, Trading Partner Profile Registrations must be completed.
2. On or after May 5, 2017, testing for IAIABC EDI Claims Release 3.0 must begin.
3. On or before October 13, 2017, testing for IAIABC EDI Claims Release 3.0 must be completed.
4. On or before November 3, 2017, depending on your reporting schedule, ensure the last reportable Release 1 file to IIC is received by IIC.
5. On and after November 4, 2017, continue to report the applicable paper report(s) on claims that were initially reported via EDI IAIABC EDI Claims Release 1.0 prior to November 4, 2017.
6. On and after November 4, 2017 do not send paper report(s) on claims that are now reported via EDI IAIABC EDI Claims Release 3.0.
7. On and after November 4, 2017 depending on your EDI reporting and transmission schedule, send the first reportable claims via IAIABC EDI Claims Release 3.0 file to IIC's EDI Vendor-ISO.

Paper Reporting:

1. On or before March 17, 2017, Trading Partner Profile Registrations must be completed.
2. On or after May 5, 2017, testing for IAIABC EDI Claims Release 3.0 must begin.
3. On or before October 13, 2017, testing for IAIABC EDI Claims Release 3.0 must be completed.
4. On or before November 3, 2017, depending on your reporting schedule, ensure the last reportable paper report to IIC is received by IIC. All paper forms (IC Form 1A-1 Employers First Report of Injury or Illness) not received by IIC on November 3, 2017 by 5:00 PM MST, must be submitted electronically per the Event Table effective on the mandate date November 4, 2017.
5. On and after November 4, 2017, continue to report the applicable paper report(s) on claims that were initially reported via paper report(s) prior to November 4, 2017.
6. On and after November 4, 2017 do not send paper report(s) on claims that are now reported via EDI IAIABC EDI Claims Release 3.0.
7. On and after November 4, 2017 depending on your EDI reporting and transmission schedule, send the first reportable claims via IAIABC EDI Claims Release 3.0 file to IIC's EDI Vendor-ISO.

All paper forms (IC Form 1A-1 Employers First Report of Injury or Illness) not received by IIC on November 3, 2017 by 5:00 PM MST, must be submitted electronically per the Event Table effective on the mandate date November 4, 2017 .	11/3/2017
EDI Claims R3.0 in Production (11/4/2017)	
IIC accepts Release 3 data from all Trading Partners and Vendors. Depending on your EDI reporting and transmission schedule, send the first reportable claims via IAIABC EDI Claims Release 3.0 file to IIC's EDI Vendor-ISO.	11/4/2017
Continue to report the applicable paper report(s) on claims that were initially reported via paper report(s) or via Release 1 prior to November 4, 2017.	11/4/2017
Do not send paper report(s) on claims that are now reported via EDI IAIABC EDI Claims Release 3.0.	11/4/2017
