Transitioning from Release 3.0 to Release 3.1


Since Idaho has been receiving EDI Release 3.0 FROIs and SROIs since 2017, we are not going to focus this training on what is in each tab of the R3.1 requirement tables, as we feel confident you are already familiar with those.

R3.1 Trading Partner Profile Registration for Claim Administrators

There is no need to re-register for EDI Claims R3.1 if you are currently approved with IIC for EDI Claims R3.0 reporting.

Remember that this migration to R3.1 eliminates all paper claim filings, so you will want to ensure your profile includes the carriers on those older claims.

Idaho Release 3.1 Implementation Timeline






Idaho Release 3.1 Implementation Timeline

Idaho will be transitioning from Release 3.0 (R3.0) to Release 3.1 (R3.1) for the electronic reporting of First Reports of Injury (FROI) and Subsequent Reports of Injury (SROI).

Effective December 1, 2022, use of the R3.1 standard will be mandatory for <u>all</u> IIC trading partners for <u>all</u> claims.






Idaho Release 3.1 Implementation Timeline

Wednesday, November 30, 2022, is the last day that R3.0 data will be accepted by IIC.

All R3.0 reports not received by IIC on Wednesday, November 30, 2022, by 11:59 PM EDT and accepted must be submitted to Verisk electronically per the Event Table effective on the mandate date December 1, 2022.

Effective Thursday, December 1, 2022, electronic reporting via Release 3.1 will begin for all Trading Partners.

Idaho Release 3.1 Implementation Timeline

Trading Partner/EDI Vendor Testing: Available 6/30/2022 Refer to the ID Test Plan for details

Release 3.1 Testing is to be completed by: 11/23/2022

Last Submission of Release 3.0: must be received by Idaho no later than 11/30/2022 by 11:59 PM ET

Release 3.1 FROI SROI Reporting begins: 12/1/2022

Release 3.1 Acknowledgements will be returned no later than: 12/09/2022



Expanded Processing Schedule

Morning Files – files received before 11:30 am ET will be processed in the morning run with AKC returned starting at 12:30 pm ET.

Afternoon Files – files received after 11:30 am ET and before 3:30 pm ET will be processed in the afternoon run with AKC returned starting at 4:30 pm ET.

Evening/Night Files – files received after 3:30 pm ET and before 11:59 pm ET will be processed in the overnight run with AKC returned starting at 1:00 am ET.

Web Entry [wcPrism] – submissions must be completed by 6:00 pm ET to be included in the overnight run.

Connection – Trading Partners may connect and upload files 7 days a week.







Legacy Claims Reporting:

A FROI UR (Update Report) is required for any medical or indemnity claim that is open and previously reported on paper, in R1 or in R3.0 for which the Date Claim Admin Had Knowledge of Injury is < 12/01/2022, prior to submitting any FROI or SROI in R3.1.

The FROI UR is intended to match a claim previously reported in R3 and to "set the picture" for R3.1 reporting.

Following the FROI UR, a SROI UR or the applicable SROI per sequencing should be reported.

If Benefits or Other Benefits were reported in R3.0, a SROI UR is expected and the appropriate Benefits or Other Benefits previously paid should be present on the UR.

Please review the Event Table for details.



How does the transition work?

Reporting Legacy Claims:

Legacy Claims properly filed: A Legacy claim that is required and properly filed is defined as any claim previously reported in Release 3.0 for which a Jurisdiction Claim Number (JCN) has been assigned.

Legacy Claims not properly filed: A Legacy claim where the Date Claim Administrator Had Knowledge of the Injury (DN0041) is prior to 12/01/2022, that is required and not previously reported in Release 3.0, and no Jurisdiction Claim Number (JCN) has been assigned.



New Claims Reporting:

Report New Claims: Claims that are new and have never been reported in Release 3.0 to Idaho.

What EDI reports should be sent for New Claims?

FROI: For each new claim, review the FROI Event Table to determine which event would cause you to report the claim to Idaho.

SROI: Following the FROI report, review the SROI Event Table to determine what SROI reports should be sent to Idaho after the FROI, and review the Sequencing Table to determine what MTCs are allowed to follow prior MTCs.







Trading Partner and EDI Vendor Testing begins 6/30/2022

Idaho's EDI Claims vendor, Verisk, will review and approve all testing.

EDI vendors utilized by Idaho Trading Partners will complete the test plan on behalf of their clients.

Idaho may specify which trading partner's claims must be used for testing by the vendor and vendors may be asked to complete multiple test plans using data provided by multiple trading partners.

Once the vendor is approved for production, the various Trading Partners will *likely* be approved for production; however, if a specific Trading Partner's data fails testing, <u>that</u> Trading Partner may not advance to production until testing is completed successfully. Essentially, a vendor may advance to production, but they may be suspended from filing for specific Trading Partners until that Trading Partner completes successful testing.



Trading Partners who are planning to file Release 3.1 FROI/SROI reports directly with Verisk without using an EDI Vendor will be required to complete the test plan on their own behalf.


Idaho Jurisdiction Web Entry users are not required to test.




How to begin testing?

The 5 Test Stages of Testing

Stage 1: EDI Trading Partner Profile Electronic Registration

Stage 2: Pretest and Technical Capability Test

Stage 3: Business Content Test (FROI)

Stage 4: Business Content Test (SROI)

Stage 5: Idaho Test Completion (FROI and SROI)



The 5 Test Stages of Testing

Stage 1: EDI Trading Partner Profile Electronic Registration

Ensure you have an existing EDI Trading Partner Profile Electronic Registration. Please note that the information on the registration is used for both testing and production reporting.

Stage 2: Pretest and Technical Capability Test

Complete the technical capability test to ensure that the file structure is valid per the IAIABC EDI Claims Release 3.1 standards. This portion ensures that the Header Record is populated with the correct Sender ID, the Receiver ID and other data validations. The file structure/format for the test files must be correct.



Stage 3: Business Content Test (FROI)

The business content test for FROI requires at a minimum the FROI MTCs (00 01 02 04 UI UR) to be tested in accordance with Idaho's R3.1 Test Plan.

We want to emphasize that Idaho will be validating Insurer FEINs and Policy Number Identifiers on FROIs against their policy database for test and production claims. You must test with valid Policy Numbers and Insurer FEINs, even if the rest of the claim may not be real claim data.

Please note that part of the FROI test will include a requirement to submit at least (5) FROI URs for an existing legacy claim using Dates of Injury prior to 01/01/2022.

When considering the FROI reports that will be tested, it is recommended that a <u>review</u> of Stage 4 SROI testing be performed at the same time to determine if additional FROI test reports are needed to establish claims in order to successfully complete the SROI testing.



Stage 3: Business Content Test (FROI) continued

Upon completion of Test FROI Batches 1 and 2, the Trading Partner and/or their EDI Vendor should request testing approval by completing and submitting the Idaho EDI Testing Feedback Request List R3.1.

The Feedback Request List will list all the completed FROI test claims required by Idaho's Test Plan and should be sent to Idaho's EDI email.

Idaho will then notify the Trading Partner by email if the Trading Partner has passed the FROI testing and is approved to proceed with SROI testing.



Stage 4: Business Content Test (SROI)

The business content test for SROI requires at a minimum the SROI MTCs (02 04 AB AN CA CB CD EP ER FN IP NT PD PY PX RB SX UI UR VE) to be tested in accordance with the Idaho R3.1 Test Plan.

Please note that part of the SROI test will include a requirement to submit five (5) SROI UR's with a Date of Injury *prior to* 01-01-2022.

Because the SROI testing builds on the accepted FROIs, ensure that there is an adequate number of FROIs reported in Stage 3 to meet the SROI testing needs in Stage 4. For SROI reporting, please pay special attention to sequencing.

FROI and SROI testing should be completed by November 23, 2022.



Stage 5: Test Completion (FROI and SROI)

Upon completion of the SROI minimum test transactions, the Trading Partner and/or their EDI Vendor must request testing review and approval from Idaho/Verisk by submitting the **Idaho EDI Testing Feedback Request List R3.1** to Idaho 's EDI email.

Stage 5 is requesting and being approved for SROIs which will mean you are approved for Production for FROI and SROI reporting effective December 1, 2022.

Test/Production Indicator:

The Test/Production Indicator on the Header Record will need to change from T (Test) to P (Production) to indicate that the records contained in the file are production data.

Trading Partner Profiles must be kept up-to-date.



Idaho Event Table



The Event Table tells you the MTC and its Description; and it is required from the R3.1 mandate date of December 1, 2022.

It also identifies the Idaho FROI Report Trigger Criteria which indicates the circumstances under which a FROI report should be sent.

It also indicates when the MTC should be triggered and when the report is due (which means when it must receive a TA – Transaction Accepted).

If it is required by ID Statute or Rules, they will be listed in the next columns, along with what paper form may be due to be sent, and the parties that should receive a paper form copy.

The Event Table tells you the details of the Report Trigger Value which indicates the circumstances under which a FROI report should be sent, and sometimes when it does not need to be sent. The MTC FN is a good example of this.

Additions – FROI 02 Match Data changes are to continue to be reported for 5 years after FN filing



Idaho Event Table Changes

What data is needed on the EDI reports?

The Element Requirement Table lists every data element on the FROI and SROI.

Idaho has identified whether a data element is required on a certain MTC transaction with a specific requirement code on the table.

If a data element is conditionally required (MC), the FROI and SROI Conditions tab further clarifies under what conditions that data element is required.



If MC or EC is applied then the condition must indicate that DN0192 Benefit Payment Issue Date can only be mandatory for IP, AP, PY, RB, SX or any corresponding 02 for those specified Maintenance Type Codes: Per DP Rule: Payment Issue Date (DN0195) The Steering Committee/EDI Council directed that Payment Issue Date (DN0195) was established for specified transactions only (IP, AP, PY, RB, or any corresponding 02 for those specified Maintenance Type Codes) and that individual weekly check information would not be reported.



Changes for R3.1

Overpayment Amount - Current

R3.1 introduced a new DN to report an **Overpayment Amount** of indemnity benefits on the claim. Idaho is accepting this DN if it is applicable to the claim.

Please refer to the definition and DP Rule in the Implementation Guide to determine how it should be reported, if applicable.

MTC 02 Change Process

One of the primary reasons Release 3.1 was created was to improve the 02 Change process. In Release 3.0, a jurisdiction could just enter a Y in the 02 column if they wanted to know if a DN was changed.

Most jurisdictions like to know about the adding or removing of a DN but do not want to know every time a DN was updated in a Claim Administrator's system, especially financials, unless it was initially reported incorrectly and is being changed.

A claim administrator's system cannot determine if a change is being made because the data was incorrect or the data was just being updated.

This resulted in numerous 02s being triggered to jurisdictions unable to identify what data was being changed on the transaction.

Release 3.1 has developed a specific 02 Change variable segment on the FROI and SROI to help resolve this.

Element Requirement Table MTC 02 Change Process



A new 02 Change variable segment was created on both the FROI and SROI.

This segment contains new data elements created to identify the data element (DN) or variable segment that is being changed and the reason:

DN0412 - Change Data Element/Segment Number and

DN0413 – Change Reason Code

The new Change Reason Codes are:

A = Add - A DN was previously blank/null in the database and has been changed to a value.

U = Update - A DN was previously a value in the database and has been changed to another value.

R = Remove - A DN was previously a value in the database and has been changed to blank/null. Used for DNs not in a variable segment.

D = Delete - A variable segment occurrence has been removed <u>in its entirety</u>. Data elements within the segment are not required to be identified in the change variable segment as Remove.

Please refer to the R3.1 Element Requirement Table Instructions and Implementation Guide Data Dictionary for the Data Population rules for these DNs. Please also thoroughly review the 02 Change Processing Rules in Section 4.

The IAIABC has created Reportable Change Codes for a jurisdiction to use to identify whether an 02 Add, Update, Remove or Delete will be accepted.

Some of these codes also identify which report (FROI or SROI) the change should be reported on. The legend of these codes is found in the Instructions tab at the front of the ERT.

REPORTABLE CHANGE CODES used on Idaho's Element Requirement Table are as follows:

Reportable Change Codes: Used in MTC 02 Reportable Change columns labeled A (Add) , U (Update), R (Remove) and D (Delete)

Note: See IAIABC Release 3.1 Guide 02 Change Processing Rules in Section 4 for the full definitions.

- B: Restricted: IAIABC Defined No Change Allowed
- N: No Change Allowed Will Reject if Present (DN is not in a Variable Segment): Claim Administrator will not generate a MTC 02 Change. MTC 02 will reject if the DN is present in Change Variable Segment in DN0412 Change Data Element/Segment Number. Exception: When all MTC's for a given DN have 'NA' Requirement Code.
- N: No Change Allowed Will Reject if Present (DN is in a Variable Segment): Claim Administrator will not generate a MTC 02 Change when the data element with Reportable Change Code of N is the only DN in the variable segment that has changed. The MTC 02 will reject if the DN is present in Change Variable Segment in DN0412 Change Data Element/Segment Number. Exception: Will not reject transaction when the Requirement Code for all MTC's for a given DN have 'NA' Requirement Code.
- Y: Required Change on FROI or on SROI: This code applies to Data Elements only on FROI or only on SROI. These DN's are not on both the FROI and SROI.
- YG: Required Change on FROI or on SROI with Exception: This code applies to Data Elements only on FROI or only on SROI. These DN's are not on both the FROI and SROI.
- K: Required Change on FROI not on SROI: This code applies to Data Elements on both the FROI and SROI and change is required on FROI.
- KG: Required Change on FROI not on SROI with Exception: This code applies to Data Elements on both the FROI and SROI and change is required on FROI.
- J: Required Change by Transaction Type Change on SROI if Accepted otherwise Change on FROI if Accepted: This code applies to Data Elements on both the FROI and SROI.

 Claim Administrator will generate a MTC 02 Change on the SROI only if a SROI has been previously accepted. If no SROI has been previously accepted then a FROI MTC 02 Change is required unless the jurisdiction indicates they do not want a FROI 02 Change triggered by using Code H or N on the FROI.
- JG: Required Change by Transaction Type with Exception Change on SROI if Accepted otherwise Change on FROI if Accepted: This code applies to Data Elements on both the FROI and SROI.

 Claim Administrator will generate a MTC 02 Change on the SROI only if a SROI has been previously accepted. If no SROI has been previously accepted then a FROI MTC 02 Change is required unless the jurisdiction indicates they do not want a FROI 02 Change triggered by using Code H or N on the FROI.

Note:

02 Requirement Code column is populated with NA and the DN is on both FROI and SROI. When the 02 Requirement Code is set to NA (Not Applicable) then a MTC 02 Change should not be generated based on the specific FROI or SROI DN however the Reportable Change Code will provide the expectation if a MTC 02 Change is still needed on the other report type. If the 02 Requirement Code on the other report type is not set to NA (Not Applicable), then refer to the 02 Reportable Change Code(s) for the other report type. Example DN on both FROI and SROI - MTC 02 needed on FROI: DN0052 Employee Date of Birth has 02 Requirement Code set to MC on FROI and set to NA on SROI. The Reportable Change Code for both FROI and SROI is set to K (Required Change on FROI) for Add, Update and Remove because 02 Change Rules say Reportable Change Code must be applied consistently across both the FROI MTC 02 and SROI MTC 02 Change for K. In this example, a change for this DN must be generated on the FROI MTC 02 and not the SROI MTC 02

For **DN0412 – Change Data Element/Segment Number** Claim Administrators must identify the Change Data Element/Segment Number of the data that is changing.

If the data that is changing is NOT in a variable segment, you will send the DN data element number for the data element that is changing.

If the data that is changing is IN a variable segment, you will send the Variable Segment Counter data number (DN). These are the "Number Of" Data elements.

Idaho's Edit Matrix

The Idaho Edit Matrix defines the valid code values Idaho accepts, the Match Data that will be used to match transactions and the edits that will be applied to the EDI data.

It conveys the specific edit that will be applied to each data element and provides the standard error messages associated with these edits.

This spreadsheet is important for understanding and correcting errors.



All Data Elements on the FROI and SROI have a 4 digit "DN" Data Number that is used to identify the data element on the Acknowledgement.

Every Error also has an Error Number. These DN Number and Error Number combinations present on the acknowledgment can be used to find the error in this DN Error Table or the Population Restrictions tab, which further explains more complex edits.




